Obedience

In the course of human events there comes a time when something must be said and something must be done to bring balance back to the moral center of our society. The concept of civility is somehow become foreign to a society that once prided itself on just how civil it was. There was a time when parents, teachers, and students all understood the important role that civil behavior played in our society and made sure that that was the first lesson taught. That notion today is laughed at as our society continues to spiral out of control

and the greatest minds of our generation have yet to figure out what happened or how and who to fix it. What is needed is a return to the core values that made our society great, an honest recognition of what has failed and a ceasing of the practices, programs and yea even the mind set that contributes to this continuous breakdown. What is needed is a call to or **Declaration of Civil Obedience**.

Two events in the last half of the twentieth century have brought about the instability and out of balance that I speak of. Those two events were the banning of public school prayer and integration. One of the book's central characters, James Otis, makes a statement that clarified in the hearts and minds of the early revolutionaries just why they were fighting. Otis said it was not just for the rights of men in this country, but just so a man could stand any where in the world. "Just so a man could stand." America's resolve has always been that God has given us the strength and the wherewithal to stand; to stand anywhere, anytime, and anyplace. If God is no longer seen as the principle of our resolve, then what do we stand for? There is an old adage that states that a man who will not stand for something will fall for anything. I fear that that is where we are.

" If my people, which are called by my name, shall humble themselves, and pray, and seek my face, and turn from their wicked ways; then will I hear from heaven, and forgive their sin, and will heal their land". America needs healing, but before it can be healed we must first recognize that our wound was self inflicted. We must turn back to our core values and not be afraid to stand on those core values as we face the monumental challenges that face us as a nation. If the men and women who make the laws that govern this country dare not begin their congressional day without prayer, if our president takes the oath of office with his hand on the Holy Bible and swears to protect and defend our country "so help me God" why is it so difficult to

accept the fact that our schools need to invoke the presence of God.

Return prayer to public schools. If there is a conscience among the students and teachers that a greater power, or higher authority is at work amongst them, I believe that this will cause a change for the better in the dynamics of the educational environment. Teach our children that good citizenship is not just a privilege to be taken lightly, but a responsibility that must be live up to in order for our society to fulfill its promise.
